

The Early Settlement Mediation Program is Available to Resolve Landlord-Tenant Disputes

Due to the coronavirus, the Oklahoma Supreme Court has ordered that the courts remain closed until May 15, 2020. This means that no court hearings will be held and no eviction orders will be issued until after the courts reopen.

Can I still be evicted?

The Court Clerk is still accepting petitions for eviction. This means you may receive court paperwork that the eviction process has started. If you received a court summons you must go to court at the date and time listed in the Summons. But first, you should call the Court Clerk to verify your court date since many court dates are being temporarily postponed.

If you receive court paperwork, that this does not mean you need to move. You will be given an opportunity to tell your side of the story to a judge before an eviction order is granted, unless you fail to go to court as instructed. No one can be ordered to leave their home until after their court date. The landlord cannot lock you out of your home without a court order, and the landlord cannot terminate your utilities under any circumstances.

When can I request mediation with my landlord?

For tenants experiencing difficulty paying rent due to financial hardship or other disagreements with their landlords, the Early Settlement Mediation Program is available. The Early Settlement Mediation Program provides mediation services to resolve disagreements between tenants and landlord, including non-payment of rent, lease violations, maintenance problems, and other disputes

What is mediation?

A mediation is a meeting with a neutral, third party to help the tenant and landlord resolve their disagreement and come to a agreement that will benefit both of them.

What is the Early Settlement Mediation Program?

The Early Settlement Mediation Program is a free mediation program sponsored by Tulsa County and the Oklahoma Supreme Court. The mediators are professionally trained and certified by the Oklahoma Supreme Court.

You can apply for services from the Early Settlement Mediation Program. There is no cost for either the application or the mediation.
